GUIDANCE NOTES

This form is to be used for the application for financial assistance from the 16 - 19 Bursary Fund. Any false declaration could result in future payments being stopped and incorrectly paid funds recouped.

Eligibility

To receive a bursary, the young person must be over 16 on 1st September and be under 19 on 31st August in the academic year in which they start their programme of study.

There are two types of awards from the Bursary Fund:

Bursary - Vulnerable Young People

This group covers young people who are looked after by the Local Authority (In Care), care leavers, and those in receipt of Income Support and disabled young people in receipt of both Employment Support Allowance and Disability Living Allowance. The award for this group of young people is £1,200 per academic year, and will be allocated by the ESFA via the school if their criteria is met.

Discretionary Bursary

A Bursary of £600 per academic year could be awarded to young people in receipt of free school meals.

The 16 - 19 Bursary is designed to help support young people who face financial barriers to continuing in education and training after the age of 16, and can be used towards the costs of transport, books and equipment.

The College will retain a hardship fund to cover the cost of bursaries awarded throughout the academic year due to changes in the financial or domestic circumstances of individual Students, or in cases of exceptional circumstances.

Details of the timings and conditions of any payments can be found in the College's 16 - 19 Bursary Policy.
