#### **GUIDANCE NOTES**

This form is to be used for the application for financial assistance from the 16 - 19 Bursary Fund. Any false declaration could result in future payments being stopped and incorrectly paid funds recouped. ICC will administer the 16-19 Bursary funding as per guidance provided by the Education Funding Agency. Any appeals should be made following the school's Complaint Policy, which is available on out website.

#### **Eligibility**

To receive a bursary, the young person must be over 16 on 1st September and be under 19 on 31st August in the academic year in which they start their programme of study.

All Bursary applicants will the individually assessed to identify financial need.

There are two types of awards from the Bursary Fund:

#### **Vulnerable Bursary:**

This group covers students who are looked after by the Local Authority (In Care), care leavers, and those in receipt of Income Support, and disabled students in receipt of both Employment Support Allowance and Disability Living Allowance. The award for this group of young people is up to £1,200 per academic year, and will be allocated by the ESFA via the school if their criteria is met.

#### **Discretionary Bursary:**

The 16 - 19 Bursary is designed to help support individual young people who face financial barriers to continuing on their programme of learning at ICC after the age of 16, and can be used towards the costs of transport, books and equipment. Receipts will be required.

The amount of Bursary funding awarded will be based on financial information provided at the time of application. Wider considerations that impact on the financial ability to attend a programme of learning will also be taken into account.

The College will retain a hardship fund to cover the cost of bursaries awarded throughout the academic year due to changes in the financial or domestic circumstances of individual students, or in cases of exceptional circumstances.

Details of the conditions of any payments can be found in the College's 16 - 19 Bursary Policy, which is available on the school's website or by contacting the 6<sup>th</sup> form office.
